Wedgewood HOA has established the following policies to insure fairness in the use of our facility. Applicant agrees to read and abide by the following rules and guidelines.

1. Reservation dates and times will only be confirmed with a rental agreement signed by both the pool manager (or authorized agent) and the lessee booking the party. All parties will be allotted 2 hours. Rental agreement must include \$50 non-refundable deposit.
2. You may arrive to set up for your party 15 minutes before scheduled party time. Swimmers may be asked to exit the pool 10 minutes prior to party end time to expedite clean-up and exit. Clean-up and exit should be no longer than 10 minutes beyond scheduled party end time. Please remove all decorations and dispose of trash properly.
3. NO ALCOHOL. NO GLASS CONTAINERS. NO SMOKING WITHIN POOL FACILITIES. NO CONFETTI. OR PLASTIC LEIS.
4. The "Kiddie Pool" will be opened for use upon request. However, an adult guest must stay within the gated area. LIFEGUARDS WILL NOT BE SUPERVISING KIDDIE POOL AREA. No diapers allowed in either pool.
5. Swimmers must shower before swimming. Long hair must be in a ponytail, braided, or otherwise tied back. Swimmers may be asked to prove swim ability to lifeguard prior to using diving board. Posted pool rules must be observed. Guests may be asked to leave for non-compliance.
6. Please advise lifeguards as necessary of any swimmers with medical conditions that may require special attention.
7. **CANCELLATION POLICIES:** There will be no refund of party fees. You may reschedule based on availability without losing your deposit. If the party must be cancelled due to inclement weather (storms, lightning, tornado watch), you may either reschedule or have your \$50 deposit refunded. Cancellations for any other reason will result in forfeiture of \$50 deposit.

Applicant agrees to accept responsibility for damage done to Wedgewood Pool property during their party. Applicant also agrees to hold harmless Wedgewood Homeowners' Association, its employees, and agents from and against any claims for damages to persons or property arising out of the use of Wedgewood Pool facilities.
